Scope and content

Dr. Vincent A. Jablon was a podiatrist and professor of Roentgenology, who received from the University of Miami in 1931. While at the University of Miami, he worked for the Curtiss Airplane and Motor Company and was part of the Omicron Phi fraternity, which was based on the interest in aviation. The Vincent A. Jablon papers contain materials pertaining to these topics, in the form of scrapbooks of Omicron Phi activities, photographs of Curtiss airplanes, clippings, Jablon's mechanic identity card, letters, photocopies, Jablon's 1930 class schedule, and his jacket, goggles, and pilot hat.
