**A. EXECUTIVE SUMMARY AND OUTLINE INTRODUCTION**

Active work on this text commenced following a conversation with Dean Elizabeth Plater-Zyberk, FAIA, in February 1997, during which she suggested that I prepare a history of the School of Architecture. Since that time I have agreeably spent many hours in research in the UM Richter Library (Archives and Special Collections Department) including study of past issues of the various catalogs, graduation announcements, and The Miami Hurricane, as well as with my extensive collection of notes and news clippings over the past 25+ years since I joined the University. (A few years ago I was pleased to teach the son and meet the grandson of one of my 1972 B.Arch. thesis students in a much later upper level design studio!) I have received some assistance to date from the central Richter Library staff, other faculty including former Dean Roger Schluntz and Professor Emeritus Harold Lewis Malt, staff including Lamar Noriega and Jossie Garcia of the Dean's office, and other contacts.

After some consideration, I have organized the material under the following headings related to seven important periods in the development of Architecture studies at the University of Miami:

Additional sections herein cover the topics of Acknowledgements and an Index to important names mentioned in the text.

Most current readers have experience in one or more of these development periods, thereby playing a role in this history. Let me outline some of the more important early names in connection with this timeline, beginning with **George Merrick** and **Thomas J. Pancoast**. **Merrick** was the founder of Coral Gables, deeded 160 acres of the new town in 1925 to serve as the initial campus of the University of Miami, contributed 4 million dollars, and served on the initial *21 Member* Board of Regents, now a renamed and considerably enlarged Board of Trustees.

(Also on the initial Board as *Treasurer* was **Thomas J. Pancoast**, a major Miami Beach developer and father of the late architect Russell Pancoast, FAIA, and grandfather of present-day Miami architect-painter Lester Pancoast, FAIA; etc.)

The initial UM Department of Architecture was founded in 1927, and placed with other Departments: Business Administration, Education, Engineering, Law, etc.; in the then College of Liberal Arts. The 1927 catalog prophesied correctly: "At a later date (these) Departments will be developed into Schools. A School of Medicine will likewise be established." (General 1927)

The initial Architecture faculty was headed by **John Llewellyn Skinner**, AIA, former Fellow of the American Academy in Rome and past Head of Architecture at Georgia Institute of Technology, as *Instructor*, assisted by **Merrick** associates **Phineas Paist**, AIA (also a former Fellow of the American Academy in Rome and then Supervising

Architect of Coral Gables) and **Denman Fink**, then Art Director of Coral Gables, as *Consultants*. Later, **Skinner** was promoted to *Professor* in 1928 (General 1928) and

**Robert Fitch Smith, A.B. & B.Arch.'31, AIA'34, FAIA'60**, became the first UM alumnus to serve as an architecture faculty member as *Instructor*. (General 1929) Landscape Architect **Ernest F. Coe**, later known as "Father of the Everglades," was appointed *Lecturer* in 1931. (General 1931) They and other Architecture faculty joined such early other UM faculty as **Rafael Belaunde, Professor of Spanish** and father of **Fernando Belaunde-Terry'33, D.Arch.(Hon.)'86, Victor Andres Belaunde, Professor of Latin American History and Institutions** and **Marjorie Stoneman Douglas, Coach in Short Story Writing** (later *Associate Professor of English*) and Assistant Editor of The Miami Herald. (General 1929)

By mid-1929, **David Fairchild** was then *Chairman* of the UM Board of Regents, which had lost **Merrick** and **Pancoast**, among others, and was then down to *10 Members*. (General 1929)

As the new University entered the era of economic depression, the consequences for Architecture were serious. As described by the University's "Golden Anniversary" historian in 1976: "The program in architecture fell victim to the growing economic depression and possibly to the associated economic strife at the university. **Skinner** was one of the seven who challenged (*President*) **Ashe's (1926-1952)** leadership in 1932 and lost their positions. On July 14 of that year, students of architecture were advised to change to another department or another school." (Tebeau 1978) 10 students were awarded B.Arch. degrees in this original 1927-1932 program.

Some details of this story and additional chapters continue below.

## **B. THE ORIGINAL PROGRAM: 1927-1932.**

Administration

Initial Board of Regents (21) included **George E. Merrick** (Founder of Coral Gables) and **Thomas J. Pancoast**, Treasurer, (a major Miami Beach developer and father of the late Russell Pancoast, FAIA - later founder of Pancoast/**Ferendino**/Grafton, and succeeding architecture/engineering etc. firms - and grandfather of Lester Pancoast, FAIA, both prominent Miami architects). The Department of Architecture was then administratively located in the then College of Liberal Arts, which also included other Departments:

Business Administration, Education, Engineering, Law, etc. Prophetically:

"At a later date (these) Departments ... will be developed into Schools. A School of Medicine will likewise be established." (General 1927) This all was finally accomplished in a series of steps 56 years later, in 1983 with the founding of the School of Architecture; and architecture related developments are recorded herein.

Department Leadership

**John Llewellyn Skinner** 1927-1932, AIA, *Professor and Chairman, 1927-1932.*

Chronological Details

The 1927 University catalog states (p. 16): "The University had its beginning in 1925.... ...**George E. Merrick**, founder of Coral Gables, provided a campus of one hundred sixty acres...and pledged four million dollars toward the University's

endowment.... The citizens of South Florida have pledged an additional three million dollars.... ...classes started their work October 18, 1926. The University at present consists of A College of Liberal Arts and a School of Music .... Tuition ... is \$225 a year.... The College of Liberal Arts includes Departments of Business Administration, Education, Architecture, Engineering, and Law ...." and "At a later date (these) ...Departments...will be developed into Schools." (General 1027)

The initial Architecture faculty was: **John Llewellyn Skinner 1927-(1932)**, B.A. Sc., U. Toronto, M.Arch. and Robinson Traveling Fellowship, Harvard U., Fellow of the American Academy in Rome, (AIA'22, FAIA'49).... (formerly Head of the Department of Architecture at Georgia Institute of Technology,) *Instructor in Architecture*; **Denman Fink 1927-(1926-1956)**, (Pittsburgh) Museum School of Fine Arts, Art Students League of New York City, ...(Art Director of Coral Gables), *Consultant in Architecture*; and **Phineas E. Paist 1927-(1932)**, Pennsylvania Academy of Fine Arts, Cresson Traveling Scholarship, ..., (also, like, **Skinner**,) FAAR, AIA, ....(Supervising Architect of Coral Gables), *Consultant in Architecture*. This catalog outlines three initial Architecture course topics to be offered. (General 1927)

In March 1928, a four year. B.S. Architecture degree program was announced in The University News. (Architecture 1928) The later 1928 University catalog specifies the first two years of the Architecture curriculum and outlines eight Architecture course topics. (General 4/1928)

The 'Curriculum for Architecture' listing in the 1929 catalog (p.30) details: "The first three years of a four year course in Architecture providing the necessary training in Design, Construction, and allied subjects to fit the student for the practice of Architecture .... Since Architecture is regarded primarily as a Fine Art, Design is the major subject pursued, the problems in Architectural Design of the Society of Beaux-Arts Architects in New York are taken throughout the course (degree program) and submitted in



competition with work done at northern and eastern Schools of Architecture." 13 architecture course topics are now outlined one year later. (General 4/1929)

In the following year, it was proudly announced: "The department now offers the complete four-year course (126 credits, p.29-30) required for the degree Bachelor of Arts in Architecture." 20 architecture course topics are listed. (General 7/1930)

Grace Manly delivers a Young Women's Christian Association talk on the value of Architecture as a profession for women, indicating a leadership interest in woman's careers, and was reported in The Miami Hurricane. (Vocational 1930)

The (4-year) degree program was renamed Bachelor of Architecture, and is now a 134 credit program. 13 architecture course topics are listed. (Architecture 1930)] (General 7/1931)

The Miami Hurricane covers several important program events in October 1930: students enter Beaux Arts Competition; Prof. **Skinner** appointed as Department Head; 14 new freshmen architecture students; architecture student **Clinton Gamble'31**, (AIA'36, FAIA'62) listed as Business Manager of The Miami Hurricane. [See also similar Beaux Arts stories in Hurricane Vol. 5, #10, "Architecture Students Send Plans to New York," Hurricane Vol. 6, #5, "Four Architecture Students Submit Competition Designs," and Hurricane Vol. 6, #6, "Architecture Students Submit Problems to Beaux Arts."]  
(Architecture 10/1930)

Architecture faculty and students travel to Ft. Myers on December 4, 1930, to attend Florida Architectural Association Convention. (Prof. **Skinner** and 6 students: **Haring'31, Gamble'31, Weakl(e)y'31, La(r)ing'32, Baxter'31 and Smith'31.**)  
(Architects 12/1930)

The December 1930 Hurricane reported that The Florida Architectural Association (now Florida/Caribbean Association, AIA,) was to inspect the Architectural school to gain state recognition for graduates and to foster Association of Collegiate Schools of Architecture admittance.] (Architecture 12/1930; Tebeau 1976, p. 80; FSBA 1978)



The **first** student recipient of an architectural design prize was **Robert Fitch Smith'31**, who wins this prize for a bathroom design from Southern Sanitary Manufacturing Company. (Architectural 1931)

**Clinton Gamble'31** is listed as "Architectural Editor" of The Ibis yearbook and **Robert Fitch Smith'31** is listed as a Justice of "The Honor Court;" a prominence in student activities seldom matched by architectural classes in later years. (The Ibis 1931, Yearbook 1932)

The first University of Miami architecture program initially graduates five students on June 12, 1931 at 8 p.m. in the Miami Biltmore Club: **Edward Hart Baxter B.Arch.'31** (R.A., AIA'45), **George Clinton Gamble B.Arch.'31** (R.A., AIA'38, FAIA'62), **Walter James Haring B.Arch.'31, Magna Cum Laude**, **Robert Fitch Smith B.Arch.'31** (R.A., AIA'34, FAIA'60) and **Raymond DeC. Weakley, Jr. B.Arch.'31**. (Bachelor 1931, Gane 1970, Johnston 1992)

Preliminary student registration figures for the fall semester '31-'32 (29 Sept. 31) show: University total = 510; Architecture = 6 Fresh., 7 Soph., 4 Jr., 6 Sr. = **25 + 2** Special, over 5% of the total University enrollment. (Preliminary 1931)

In February 1932, the Hurricane reported the election of officers of the Architectural Society. (Architectural 1932)

The Hurricane featured a story that the Architecture Department had held its Second Yearly Exhibition. The 23 students whose work was on exhibition (in the girl's gym) included: ...**Andy Ferendino'34**, ...**Clinton Gamble B.Arch.'31**, **Fernaundo Balaunde(-Terry)'34**.... Also, the Tau Sigma Delta Chapter was founded. (Architecture 1932)

All Architecture students were made Charter Members of the Junior Architects Club of the Miami Women's Club, and 7 students' (both male and female) work was exhibited at the Club. (Architecture 1/1932)

The five 1932 graduates on June 6 at 8 p.m. in the Miami Biltmore Club were:

### C. DEPRESSION AND WWII ERA CONSOLIDATION: 1933-1949.

#### Chronological Detail

The 1934 Bulletin lists anew "...**Denman Fink**, Portrait and Mural Artist, Illustrator, Exhibitor, *Professor of Painting*...." (No listing of any early Architecture related faculty in 1932-1933 and 1933-1934. This new type of faculty listing for **Denman Fink** in *Painting* or *Art*(1950's) was continued in succeeding issues of the Bulletin until the retirement word *Emeritus* was added in his *Professorial* title in those of 1952-1953 through 1956-1957 when he was listed as "**Denman Fink 1926-Professor of Painting Emeritus.**") Thus **Denman Fink 1926-1956**, represents a continuity of UM design faculty presence from the initial Architecture faculty through the first short appointment of **James Branch 1946, 1950-1972**, in 1946 and **Branch's** later continuing appointment beginning in 1950 before **Fink's** retirement and end of active service. (Bulletin 1934)

This 1938 publication lists final total University Enrollment by year from 1926-1927 to 1937-1938: 461, 484, 624, 576, 735, 822, 537, 531, 795, 978, 1079, 1206. Note the major trend *discontinuity* in economic depression years 1932-1933 thru 1934-1935!]  
(Where 1938)

### Administrative Changes

## Chronological Detail

"Careers for Co-Eds," a 1951 Bulletin of the University of Miami includes 'Interior Decorator' as a major potential career, and highlights 'Design - basic, applied, *architectural*' as one of its 'Major Studies.' (Careers 1951)

There appears to have been no special celebration of the 25th (Silver) Anniversary of architectural education at the University of Miami in 1952. President **Ashe** passed on in 1952.

The Christian Science Organization Building on the Coral Gables Campus was completed as designed by **Donald Lee Brown 1954-c.1960**, (B.Arch.'51, MIT, RA, AIA), *Assistant Professor of Architectural Engineering*, in 1959. He later left the University, maintaining contributions to the CSO, and became a senior architect with Reynolds Metals, Inc., in Richmond, VA. **James P. Sampson 1956-1983**, (B.S.A.E.'50, Illinois, RA), *Associate Professor of Architectural Engineering*, and **John E. Sweet 1958-1970**, (B.S.Arch.'27, M.S.Arch.'35, Illinois), initially *Associate Professor of Architectural Engineering* and retiring as *Professor of Architecture*, also began service on the faculty during this era.

### Chronological Detail

Under the "School of Engineering" heading in the 1962 Bulletin - University of Miami, the Bachelor of Architecture curriculum was re-established, now a 171 cr. five-year program, led by the faculty of the renamed Department of Architecture and Architectural Engineering: **Branch, Arthur, Nicolaides, Sampson, Sweet and West**. (Like **Denman Fink** noted earlier, **John S. West** - then former first Dean of the College of Liberal Arts, and *Professor Emeritus* - also represents faculty continuity from the 1920's through the 1960's.) 27 1-7 cr. courses. Tuition is about \$1,000 per year. (School 1962)

On December 7, 1962, *President Henry King Stanford* announced 'Home Economics Dropped From Curriculum,' effective September 1963, printed under the heading "Alumni News," in a University Bulletin. Of course, this included the Interior Design option, which was taught by architecture faculty. (Home 1962)

The faculty list in the 1966 Bulletin showed 11 Architecture and Architectural Engineering (AAE) faculty: **James Branch, Arthur, Buisson, George Clinton Gamble B.Arch.'31 1964-**, Reg. Arch. FL, OH, VA, NC., AIA'38, FAIA'62, *Adjunct Professor of Architecture*; (**Jan Hochstim B.S.A.E.'54, MA'77 1966-**; **William R. Mitchell 1967-**, B.Arch.'67 N. Carolina State University, *Instructor in Architecture*); **John Russell Nichols 1966-(1969)**, B. Arch.'65 U. Florida, *Assistant Professor of Architecture*; (**James P.) Sampson 1956-(1983)**, B.S.A.E. '50 U. Illinois, (M.S. '68 Oklahoma State U.), Reg. Arch. FL, WI, (**Thomas A.) Spain M.A.'70 (1970)1973-**, B.Arch.'66 N. Carolina State U., Reg. Arch. FL; (**John E.) Sweet 1958-(1970)**; (**Henry S.) West (1926-**), A.B. + Ph.D. Johns Hopkins U. 30 AAE courses were outlined. (Initial NAAB Accreditation was sought and was not achieved.) (Bulletin 1966)

Considering the recent non-accreditation decision by NAAB, partly due to the large amount of 1 and 2 credit courses then required, the following statement is printed in the 1969 undergraduate Bulletin: "The program in Architecture and Architectural Engineering described herein is being revised. A new program will be implemented in the fall of 1970...." It also describes, p. 372-373, "The Center for Urban Studies...(which) develops and coordinates research in... regional planning, urban affairs and environmental management." The first director of this center was *Professor Carl E. B. McKenry* A.B.'49, J.D.'54, LL.M.'62, from the Schools of Business and Law. (Bulletin 10/1969)

Gane's American Architects Directory of 1970 lists information on about 23,000 active architects, including important UM Architecture figures: **J. Branch, Baxter, Ferendino, Glasgow, Hochstim, Kruse, Luckman, Marmorstein, Pace, Riccio, J. Skinner, Warburton and Wilkins**; most with brief autobiographies. **Clinton Gamble B.Arch.'31, AIA'41, FAIA'62**, was an Associate Editor of this major volume (Gane 1970)

The list of degree programs (p.29 in the 1970 Bulletin) includes for the first time an "M.S. in Urban and Regional Planning." (Bulletin 1970) Under "The Center for Urban Studies," five Architecture courses are listed as "Urban-Related" on p.376 of the 1971 Bulletin. (Bulletin 1971)

*President Stanford* announces the appointment of *Professor Ralph Warburton* as Chairman of the Department of Architecture and Architectural Engineering in June 1972. (UM 6/1972) Related stories are in: 'About People.' "Memo." Washington, DC: American Institute of Architects, #451, 12 July 1972; "BRI Newsletter." 30 June 1972, etc.

At the time of this appointment, **Warburton** was Special Assistant to the Secretary (of the U. S. Department of Housing and Urban Development) for Urban Design, in Washington, DC. A graduate of M.I.T., and later, Yale University, in both Architecture and City Planning, with an engineering background and strong publication



record and considerable professional travel in most U.S. states and over 15 foreign countries including Iran and Russia, he was then licensed in 7 states from Colorado east and DC. (NCARB - and later AICP and NCEES certificated, additional licenses including FL in architecture, interior design and engineering were since achieved over time as seemed desirable for academic administration, admissions recruiting, and practice.)

**Warburton** was elected a member of Washington D.C.'s prestigious Cosmos Club, the first UM faculty member so honored, on 9 September 1972. (List 1973)

He was introduced to UM by Edward G. Grafton, AIA, initially a Partner of Russell Pancoast, and **Andrew Ferendino**'34, and later Chairman of the AIA's national Housing Committee, (of which **Warburton** was a member); **Warburton** was also then elected in 1972 a shareholder Senior Partner and Vice-President of **Ferendino/Grafton/Spillis/Candela, Inc.**, now Spillis, Candela and Partners, Inc.. His Coral Gables home about 1 mile south of the UM Campus, upon purchase becoming one of the few UM faculty homes then near the Campus in Coral Gables, had been designed by H. George Fink, AIA'45, (cousin of **Denman Fink 1926-1956**) in the 1950's.

"The University began its move from the old Anastasia Building, (at University and Riviera Drives in Coral Gables), in which classes were originally opened, to the Main Campus, where buildings were rising rapidly, in 1946. (The J. Neville McArthur Building for the School of Engineering and Environmental Design, was completed in 1958.) (The Department of Architectural Engineering was formed in 1950 and granted its first degree, B. S. A. E., in 1952 and moved to the McArthur Building with other engineering departments in 1959.) (Architecture) undergraduate tuition {was normally} \$2500 per year. (In 1961 the 5 year B.Arch. curriculum began, and its home was given an expanded name: Department of Architecture and Architectural Engineering.) In 1968, the Center for Urban Studies was established...." (Fall 1972 Architecture enrollment was **217, LOW!**) (Bulletin 12/1972)

A 220 p. multi-disciplinary Proposal to the U. S. Energy Development and Research Administration was prepared and submitted by a team of senior faculty of SEED chaired by **Warburton**, in June 1973. (**Warburton** 6/1973)

Announced in "Housing Aid Project Set by Chamber," in The Miami Herald, 10 September 1973, the new Greater Miami Chamber of Commerce "New Neighborhoods" Committee was to be chaired by **Ralph Warburton**. Expanded story by the same author, Ron Sachs, "Chamber Focuses on Housing Children," appeared on 16 September 1973. (Also covered in "Town and Gown." Veritas. Coral Gables, FL: University of Miami, 10 September 1973.) (Sachs 1973)

"News Makers" in Veritas Coral Gables, FL: University of Miami, Vol. 14 #5, 1 October 1973, lists **Warburton** participation in a French Government invitational colloquium on esthetics and urban environment at Arc-et-Senans, France. (also covered in: "Around Greater Miami." The Miami Herald. Miami: The Herald, 24 September 1973); and **Wilkins** appointment to the Dade County Historical Board. Under "Commission Hears Master Plan," **Warburton** is identified as a member of the University's Master Planning Committee. (News Makers<1> 10/1973)

Under Veritas 'Awards and Honors,' **Warburton** was initially elected a Director of the Florida South (now Miami) Chapter AIA, (**Henry A. Riccio, B.S.A.E.'53, AIA'55**, was elected President.) Under Veritas 'Miscellaneous,' **Warburton, Langendorf** and **Middlebrooks** participated in the Fourth Annual Urban Workshop for Community Leaders aboard the *S.S. Emerald Seas*, October 26-29, 1973.] (Newsmakers <2> 10/1973)

"M. S. Program in Planning Gets Nod From UM Board of Trustees." was the Veritas headline in its issue of 29 October 1973. This report mentions the initial 60 credit program and identifies planning faculty as **Warburton, Catanese** (also mentioned in "Ryder Funds Awarded" and later Dean of the University of Wisconsin, (Provost of Pratt Institute) and University of Florida Schools of Architecture, and currently President

of Florida Atlantic University), **Langendorf, Frazier, Lopez-Gottardi, Malt, Middlebrooks, Prestamo and Steel**. Similar stories appeared in: News. Naples, FL, 22 October 1973 and Progress-Bulletin. Pomona, CA, 26 Oct. 1973.) (Schnier 10/1973)

This story outlines the program for 27 Oct. and 3 Nov. sessions of the Third Annual Workshop on Planning and Zoning, sponsored by the South Florida Chapter of the Florida Planning and Zoning Association and UM SEED, School of Continuing Studies and Center for Urban Studies. Speakers included UM V.P. **Carl McKenry**, Dade County Mayor John B. Orr, Jr., Coral Gables Mayor Robert Knight, then Dade Co. and Miami Planning Directors Reginald Walters, AIP, and George Acton, AIA, AIP, then State Senator Robert Graham, architect Lester Pancoast, AIA, UM faculty **Warburton**, AIA, AIP, **Murray Mantell**, F.ASCE, **Thomas Waite**, **Howard Teas**, and others. (Plan 10/1973)

President **Stanford** and Prof. **Warburton** announce new M.S. in U.R.P. program in 1973. (New Programs 1973)

The appointment of **Warburton** as Chairman of the Greater Miami Chamber of Commerce's *New Neighborhoods Action Committee* is announced in November 1973. (Newslines 11/1973)

Veritas reported that **Catanese** gives transportation paper at the Governor's Conference on Transportation, Hawaii. (Peripatetic 12/1973)

**Warburton, Ralph**, as Professor and Associate Dean for Architecture and Planning, edited an Educational Development Plan for the National Architectural Accrediting Board, in April 1974. This Plan for expansion in quality and quantity ("...in Architecture and related disciplines envisages a total of six degree programs, not including options, enrolling a total of 700-1000 students....over a 100% expansion of the present Department...though enrollment in the first professional architecture degree curricula will be in the 400-500 student range." {Fall 1974 Architecture enrollment had then risen 187% in two years, to 401 Architecture students, + 25 students in the new graduate Urban

and Regional Planning program and +32 students in Architectural Engineering = **458 total**. {Department students.\*}) It includes *signed* endorsements by then President **Henry King Stanford**, the VicePresident for Academic Affairs **Carl McKenry'49, J.D.'54, LL.M.'62**, then Dean of the School of Engineering and Environmental Design **Howard P. Harrenstein, M.ASCE, P.E. + R.A.**, and, by the unanimous *signed* Resolution of the then 15 full time faculty of the Department of Architecture and Architectural Engineering. (After this Plan submission and approval, initial Accreditation was granted by the National Architectural Accreditation Board on June 15, 1994.))  
\*(Institutional Research Fall/1972 and Fall/1974) (**Warburton 4/1974**) (NAAB 1974)

A "Resolution of the Florida State Board of Architecture," meeting at Amelia Island, FL, 26 July 1974, commended **Warburton** for his initial architecture accreditation process leadership. (Resolution 1974)

This issue of **AIM**, edited by student **David Michael Harper, B.Arch.'74 (FAIA'95)**, features an article on "Accreditation." by student **J. J. Fernandez '75**, accompanied by two photos of **Warburton, Fernandez, and Madelin Miguez, B.Arch.'75** -- pointing out that the recently achieved accreditation was retroactive for two years so that all graduates since 1972 were deemed to have received recognized degrees; includes a major article by then Adjunct Professor **Peter Eisenman** of the Institute for Architecture and Urban Studies of New York's Museum of Modern Art; and an article on "Historic Preservation" by **Wilkins**.] (AIM 1974)

Edited by **Warburton**, then the Division Secretary-Treasurer, this newsletter featured the program (including Martin Gehner of Iowa State University and, later, Yale University) for the June 1974 annual American Society for Engineering Education conference at Rensselaer Polytechnic Institute and listed the 1973-1974 officers, which included as President G. Day Ding, AIA, then Head of Architecture at the University of Illinois-Urbana. (Architectural....1974)

The National Student AIA Chapters convention at the Coral Gables Biltmore Hotel, in the unrestored Country Club Ballroom, included presentations by Morris Lapidus, Miami Beach architect, Charles McCoy, AIA, then Mayor of Key West, and **Carol and Ralph Warburton**. (Architecture 1974)

**Frances Giller**, wife of *Adjunct Professor Norman Giller*, then President of the local AIA Florida South Chapter, leads a reorganized Women's Architectural League, whose officers include spouses of: faculty (**Carol M.M.'74, Ph.D.'81**) **Ralph Warburton**; alumni (**Lori**) **Richard Schuster'xx**; and architecture student (**Sharon**) **Max Sturman B.Arch.'75**.] (Mrs. 5/74)

**Middlebrooks** was awarded a pilot grant from the U.S. Department of Housing and Urban Development through the UM Center for Urban and Regional Studies to help provide architectural services and financing assistance through non-profit community development organizations. (Payton 5/1974)

Veritas mentions: **Hochstim** participation in the ACSA Teachers Seminar, Asheville, NC, in June; **Langendorf** representation of UM at the April meetings of the Council of University Institutes of Urban Affairs (Cleveland, OH) and the University of North Carolina Symposium on Planning Education in Chapel Hill, NC; **Warburton** session chair as director of the Environmental Planning Division at the ASPO May annual conference, Chicago, IL; and **Wilkins** historic preservation presentation on "Documentation in Dade County." (Veritas 5/1974)

The 1974 NAAB Visiting Team reported: "Chairman **Warburton** has the complete backing of the faculty and students. There appears to be no schism or factionalism among the faculty. The students also agree that the school is moving ahead and credit is almost entirely due to Chairman **Warburton's** direction and program." (NAAB 1974)

Veritas announced the **June 15, 1974 initial accreditation of Architecture**, the simultaneous 74% increase in student credit hours taught that semester - and an "upsurge

in attendance," that the masters Urban and Regional Planning Program was then the **largest university graduate program.**, and quotes *Professor Warburton* and then University *Vice President for Academic Affairs Carl McKenry.*] (Kaye 6/1974)

Then *President* Stanford announced NAAB accreditation and Commendation from the Florida State Board of Architecture, and architecture's "1980 Educational Development Plan." ( Similar stories appeared in the October 1974 Florida Contractor and Builder and the 8 September 1974 issue of The Miami Herald: "Architecture Program at UM is Accredited.)] (Architecture 8/1974) (Resolution 1974) (Warburton 1974)

The 19 September 1974 issue of Veritas featured faculty **Buisson** (sabbatical trip studying the architecture of Iran, India, Thailand and Japan), **Catanese** (then recent publications), **Hochstim** (B.S.A.E.'54, M.A.'77) (ACSA Teachers Seminar attendance), **Prestamo** (Guayaquil, Ecuador comprehensive plan work), **Warburton** (editor of federal National Community Arts Program), and **Wilkins** (National Parks Service sponsored HABS study of Drayton Hall, Charleston, SC.) Elsewhere in this issue **Wilkins** was reported to have been commended by Robert Mautz, then Chancellor of the State University System, for his task force work on the Statewide Common Course Designation and Numbering Project.] (News Makers 9/1974) The University role in the first annual Architecture Week including the Fifth Annual Urban Workshop, "Spirit of the City" to be held at the Great Harbor Club, Great Harbor Cay, Bahamas is announced. (Architects 9/1974)

"Bahama Conference Shows Miami Plans," a Progressive Architecture article, reports on the "Spirit of the City" Fifth Annual Urban Workshop sponsored by the Florida South Chapter, AIA, the Greater Miami Chamber of Commerce, and the University of Miami. Discussion included a plan for downtown Miami by Wallace, McHarg, Roberts and Todd and the **Stone** plan for Bayfront Park, and also included a debate between then Miami Mayor **Maurice Ferre B.S.A.E.'57** and fellow city Commissioner Rose Gordon.] (**Warburton** 12/1974)

"Students Open Option for Bayfront Park" was discussed by The Miami Herald on 22 Jan. 1975. [An alternative to the **Stone** plan for the park development was discussed at a Greater Miami Chamber of Commerce meeting by students, including **Tinney**, working in the UM studio of **Greenan** and William Rosenberg, ASLA.] (Buchanan 1975)

**Bowen** co-directed a meeting in San Juan, Puerto Rico sponsored by the United Nations Center for Housing, Building and Planning; **Wilkins's** illustrated lecture of Coral Gables history to its Junior Women's Club; **Warburton's** appointment as a member of the education committee of the Florida Association, AIA; and **Prestamo's** appointment to a committee to study UM faculty senate improvement: were reported. (Veritas 1/1975)

On 8 January 75 **Warburton** led a Department/University reception at President **Stanford's** residence for speakers and attendees at the major "New Federal Programs and Procedures in Government A-E Contracting Conference" in Miami.

Historic Preservation Board of Review, ("Historic Preservation") and **Ranbir Singh**, new *Visiting Instructor* ("Computers and Their Applications in Architecture.") A national planning publication presents **Malt** appointment as Acting Department Chairman and **Warburton** appointment to the National Task Force on Core Curriculum of American Society of Landscape Architects.] (The Bulletin 1976)

The MIT magazine mentions **Warburton** 1975 election as Chairman of the Architectural Engineering Division of the American Society for Engineering Education and his appointments: to the Education Advisory Board of the Florida State Board of Architecture; and to the Task Force on Core Curriculum of the American Society of Landscape Architects. (Technology 5/1976) It further discusses in "Class Review" the work of **Warburton**, as professional advisor on a national architectural competition (later known as 'Biscayne West') for the design of part of downtown Miami sponsored by the Southeast Banking Corporation.] (Technology 7-8/1976)

The maximum Architecture student enrollment to date of 521 (+ 45 B.S.A.E. and 30 M.U.R.P.) students occurred in Fall 1976; for a **total highest official historical Department/School Architectural enrollment of 596 students**, about 50% of the then total enrollment of the UM School of Engineering and Environmental Design as one of then 5 total SEED Departments. (Institutional 1976)

The Biscayne West Jury was: George Acton, AIA, AIP, then Director of Planning, City of Miami; Paul Rudolph, FAIA, Architect, New York, NY; and Harry Weese, FAIA, Architect, Chicago, IL. **Warburton** recommended the Jury and was Professional Adviser. Drawings of all entrants were exhibited in the Lowe Art Museum, accompanied by excellent student models from UM (Prof. **Warburton** studio) and the University of Florida (UF Prof. Harry Merritt studio) whose student teams competed separately with regard to an urban design for an different downtown site related to the proposed Metrorail crossing of the Miami River. Also announced in: "News Briefs." Memo. Washington: American Institute of Architects, 13 April 1976; and Clark, Sharon. "Architectural Competition Seeks New Urban Design Solutions." Veritas. Coral Gables, FL: University of Miami, 26 April 1976.] (**Warburton** 1976)

Unfortunately, no special recognition of the Architecture programs 50th (Golden) anniversary was made in Spring 1977, the strategic time of peak enrollment as noted above.

In the 1979 Bulletin, tuition is given as \$3,700 per year. It lists under 'Urban and Regional Studies,' (p. 500-503), 27 Architecture and Planning courses, more than offered by any of the other 14 UM departments covered. It also lists newer faculty: **Arthur A. B. Bowen 1975-(1987)**, B.Arch., M.Arch. and M.S. from the Polytechnic of Central London(UK). (Bulletin 1979)

On 4 December 81, **Edward Thaddeus Foote II** was inaugurated as the Fourth President of the University, succeeding **Henry King Stanford**. After retiring to Americus, Georgia, he later served a Year as Interim President of the University of Georgia, Athens, GA.

The April 1982 Veritas includes under "Faculty Promotions..." **Hochstim'54** new status as full Professor announced. Under "Honors," **Hernandez B.Arch.'80** and **Ceo** awards for summer research, the latter working with **Lombard**. "In The News" mentions **Plater-Zyberk** and **Duany** appearing on the ABC Evening News program on January 7.

Under "Look Who's Talking," indicates papers presented by **Prestamo** and **Warburton** at the Fourth National Conference on Planning History of The Fifth International Conference of the Planning History Group in Richmond, VA. (Veritas 4/1982)

**Warburton** published his Request for Proposals for Restoration/Redevelopment of The Biltmore Tower, Coral Gables, Florida. in 1982. This 230 p. extensive and complete consulting study for the City of the existing conditions of this important 1926 landmark property (often used by the University, School and Department for various functions before and after the envisioned restoration) prepared for effective use by a potential user. (**Warburton** 1982)

Mentions the 1981 Annual Report of the Zinc Institute, which contains an article about UM architecture students whop designed an entire riverfront community that makes extensive use of zinc products, designed under a research and development grant to **Warburton**. (Veritas 4/1982)

**Warburton** was interviewed on street-name games in July 1983. (Segall 1983)

**Warburton** election as President of Sigma Xi, the scientific research society, and installation as President of the Yale Planning Alumni Association, were announced. (Chapter 1983)

**Warburton's** election as President of the UM Chapter of Sigma Xi, the scientufuc research society, was reported to the University community; his wife, a University Chaplain, **Carol Warburton**, served as carillonneur at the 33rd annual Easter Sunrise Service at Coral Gables City Hall on April 3, 1983. (Veritas 6/1983)

**Warburton** received two statewide awards for his work as a consultant to the City of Coral Gables in preparing a redevelopment program for the Biltmore Tower.] (News 1983)

The 1985 University Campus Planning Competition was the **first** national or international U.S. design competition to use a specially prepared videotape (**Warburton**, *Producer*; **Malt**, *Director*) to more fully communicate the student, faculty, administration

and trustees' desires as well as historical, town, boundary and other important site conditions. The announced Jury, selected by **Warburton**, who served as *Professional Adviser*, included; **Charles Brubaker**, FAIA, Architect with Perkins & Will, Chicago, IL; **William Morgan**, FAIA, Architect, Jacksonville, FL; **Aldo Rossi D.Arts(Hon.)'87**, (Hon. FAIA), Architect, Milan, Italy; and **Paul Friedberg**, FASLA, Landscape Architect, New York City.] (**Warburton** 1985)

**Warburton** discusses the UM traffic and parking survey. (**Warburton** 1983)  
Also see related editorial "Immediate Parking Improvement Visible." (Bay 1983) Also see mention in: "Faculty Senate News:" 'Senate Ends Year in Flurry of Activity,' which includes commendation of all the work of the Senate's Master Plan Review Committee chaired by **Warburton**, and acknowledgement that the 1983-1984 Faculty Senate will include representatives from the new School of Architecture. (Zaller 1983)

Reports on survey of campus transportation by **Warburton** and Ira Sheskin of the Department of Geography. (Park 1983)

**Malt** conducted a colloquium on the Miami streetscape with the City of Miami Planning Department and the Downtown Development Authority. (Look 1983)

**Warburton** received 1983 awards from the Florida Chapter of APA and the Florida Trust for Historic Preservation for his work on restoration planning for the historic Biltmore Hotel in Coral Gables; and was also appointed a member of the Editorial Advisory Board of the Journal of the American Planning Association. **Patricios** membership and renomination to the Executive Committee of the Gold Coast Section also occurred in 1983. (Congratulations 1983)

A major story presenting findings of the study of the University campus transportation situation conducted by **Warburton** and Ira Sheskin from the Department of Geography. Omicron Delta Kappa taps **Warburton** for membership. (UM 1983)

[Beginning as Dean in January 1991, **Cenicacelaya** (also editor of Composicion Arquitectonica: Art and Architecture), announces the visiting appointments of **Scully** and **Lynn** beginning in Spring 1992. School of Architecture Alumni Association, then chaired by **Madelin Miguez Bunster B.Arch.'75**, hosts 6th Annual Library Benefit, April 12, 1991, in the Sky Lobby of the former Centrust Building in downtown Miami. Her committee members included **Robert Wade B.Arch.'68**. **LeJeune, Spain** and **Gelabert-Navia** initiate the Rome Program, teaching there in Spring 1991.
